Dog Import Checklist & Quick Guide | TailHarbor | Updated April 2026

KEY INFORMATION

SIMPLE ROUTE: EU Pet Passport accepted

| Preparation Time: | 1-2 weeks |
| Microchip: | ISO 11784/11785 (must be implanted BEFORE rabies vaccination) |
| Rabies Vaccination: | Required. Minimum 21 days before travel (primary). Keep boosters current. |
| Titer Test: | Not required (EU-listed/equivalent origin) |
| Documentation: | EU Pet Passport with current microchip + rabies records |
| Breed Restrictions: | Dangerous breeds: Staffordshire Bull Terrier, Mastiff, American Staffordshire Terrier, Tosa, Pit Bull, Boerboel, and sim... |
| Cropping/Docking: | Dogs with cropped ears or docked tails may face import restrictions in Luxembourg |
| Insurance: | Mandatory liability insurance required for ALL dogs in Luxembourg |
| Registration: | Local registration required within 2 weeks of arrival |
| Entry Points (BIP): | Luxembourg International Airport |
| Dog Tax: | €10-60/year (escalating: first dog ~€30, second ~€60, third ~€100+) |
| Import Authority: | Administration des Services Vétérinaires |

USEFUL TIPS

- Start the process as early as possible. Delays with lab results or vet appointments can push back your timeline significantly.
- Research airline pet policies early. Some airlines have limited cargo spots, especially in summer. Temperature embargoes apply above 30C / below -5C at any transit airport.
- Start crate training weeks before travel. A calm, crate-confident dog will have a much less stressful journey.
- If your dog is a restricted or mixed breed, get a breed DNA test and official documentation before traveling. Border officials in Luxembourg can refuse entry for banned breeds.
- Non-EU arrivals into Luxembourg must enter through an approved Border Inspection Post (BIP): Luxembourg International Airport.

PRE-TRAVEL CHECKLIST

EARLY PREPARATION

- Confirm your dog's breed is permitted in Luxembourg
- Research airline pet policies and book cargo/cabin spot
- Purchase IATA-approved travel crate (correct size for your dog)
- Begin crate training

MEDICAL REQUIREMENTS

- Microchip implanted (ISO 11784/11785) -- BEFORE vaccination
- Rabies vaccination administered (min. 21 days before travel)

DOCUMENTATION

- EU Pet Passport up to date with current microchip + rabies records
- All vaccination records compiled
- Copies of all documents made (2 sets)
- Airline booking confirmation printed

TRAVEL DAY

- All original documents in carry-on bag
- Crate labeled with your name, phone, destination, and 'Live Animal'
- Water dish filled and attached inside crate
- Arrive at airport early (3+ hours for international with pet)

AFTER ARRIVAL IN LUXEMBOURG

- Present documents at Travellers' Point of Entry / Border Control
- Register dog with local municipality within 2 weeks
- Register with local veterinarian
- Obtain mandatory pet liability insurance
