

# Malaysia → Slovakia

Dog Import Checklist & Quick Guide | TailHarbor | Updated April 2026

## KEY INFORMATION

STANDARD ROUTE: No titer test required

<b>Preparation Time:</b>	3-6 weeks
<b>Microchip:</b>	ISO 11784/11785 (must be implanted BEFORE rabies vaccination)
<b>Rabies Vaccination:</b>	Required. Minimum 21 days before travel (primary). Keep boosters current.
<b>Titer Test:</b>	Not required (EU-listed/equivalent origin)
<b>Documentation:</b>	Animal Health Certificate (AHC) issued max 10 days before arrival. Single-use.
<b>Cropping/Docking:</b>	Dogs with cropped ears or docked tails may face import restrictions in Slovakia
<b>Registration:</b>	Local registration required within 2 weeks of arrival
<b>Dog Tax:</b>	Dogs must not be off-leash within 50 metres of any person in public (except service/hunting dogs)
<b>Import Authority:</b>	VPS SR (State Veterinary and Food Administration)

## USEFUL TIPS

- Start the process as early as possible. Delays with lab results or vet appointments can push back your timeline significantly.
- Research airline pet policies early. Some airlines have limited cargo spots, especially in summer. Temperature embargoes apply above 30C / below -5C at any transit airport.
- Start crate training weeks before travel. A calm, crate-confident dog will have a much less stressful journey.
- Make 2 copies of every document (microchip cert, vaccination record, AHC, airline confirmation). Keep originals in your carry-on and copies in checked luggage.
- Register with a local vet in Slovakia within the first week of arrival to transfer your dog's records and get into the local pet database.

## PRE-TRAVEL CHECKLIST

### EARLY PREPARATION

- Confirm your dog's breed is permitted in Slovakia
- Research airline pet policies and book cargo/cabin spot
- Purchase IATA-approved travel crate (correct size for your dog)
- Begin crate training
- Submit pre-arrival notification (24-hour advance notification required before arrival)

### MEDICAL REQUIREMENTS

- Microchip implanted (ISO 11784/11785) -- BEFORE vaccination
- Rabies vaccination administered (min. 21 days before travel)

### DOCUMENTATION

- Animal Health Certificate obtained (max 10 days before arrival)
- All vaccination records compiled
- Copies of all documents made (2 sets)
- Airline booking confirmation printed

### TRAVEL DAY

- All original documents in carry-on bag
- Crate labeled with your name, phone, destination, and 'Live Animal'
- Water dish filled and attached inside crate
- Arrive at airport early (3+ hours for international with pet)

### AFTER ARRIVAL IN SLOVAKIA

- Present documents at Travellers' Point of Entry / Border Control
- Register dog with local municipality within 2 weeks
- Register with local veterinarian
- Obtain pet liability insurance (recommended)
