Dog Import Checklist & Quick Guide | TailHarbor | Updated April 2026

KEY INFORMATION

SIMPLE ROUTE: EU Pet Passport accepted

|----------------------------|---|
| Preparation Time: | 1-2 weeks |
| Microchip: | ISO 11784/11785 (must be implanted BEFORE rabies vaccination) |
| Rabies Vaccination: | Required. Minimum 21 days before travel (primary). Keep boosters current. |
| Titer Test: | Not required (EU-listed/equivalent origin) |
| Documentation: | EU Pet Passport with current microchip + rabies records |
| Breed Restrictions: | Restrictions on Pit Bull Terrier, Dogo Argentino, Fila Brasileiro, Tosa Inu. Wolf hybrids banned. |
| Cropping/Docking: | Dogs with cropped ears or docked tails may face import restrictions in Estonia |
| Registration: | Loomade register registration within 2 weeks of arrival |
| Import Authority: | Toiduamet / Estonian Veterinary and Food Board) |

USEFUL TIPS

- Start the process as early as possible. Delays with lab results or vet appointments can push back your timeline significantly.
- Research airline pet policies early. Some airlines have limited cargo spots, especially in summer. Temperature embargoes apply above 30C / below -5C at any transit airport.
- Start crate training weeks before travel. A calm, crate-confident dog will have a much less stressful journey.
- If your dog is a restricted or mixed breed, get a breed DNA test and official documentation before traveling. Border officials in Estonia can refuse entry for banned breeds.
- **IMPORTANT:** Estonia requires mandatory quarantine for pets. Plan well in advance and budget for quarantine costs.

PRE-TRAVEL CHECKLIST

EARLY PREPARATION

- Confirm your dog's breed is permitted in Estonia
- Research airline pet policies and book cargo/cabin spot
- Purchase IATA-approved travel crate (correct size for your dog)
- Begin crate training
- Apply for import permit from Toiduamet / Estonian Veterinary and Food Board)

MEDICAL REQUIREMENTS

- Microchip implanted (ISO 11784/11785) -- BEFORE vaccination
- Rabies vaccination administered (min. 21 days before travel)

DOCUMENTATION

- EU Pet Passport up to date with current microchip + rabies records
- All vaccination records compiled
- Copies of all documents made (2 sets)
- Airline booking confirmation printed

TRAVEL DAY

- All original documents in carry-on bag
- Crate labeled with your name, phone, destination, and 'Live Animal'
- Water dish filled and attached inside crate
- Arrive at airport early (3+ hours for international with pet)

AFTER ARRIVAL IN ESTONIA

- Present documents at Travellers' Point of Entry / Border Control
- Register dog in Loomade register within 2 weeks
- Register with local veterinarian
- Obtain pet liability insurance (recommended)
