Dog Import Checklist & Quick Guide | TailHarbor | Updated April 2026

### KEY INFORMATION

SIMPLE ROUTE: EU Pet Passport accepted

| <b>Preparation Time:</b>   | 1-2 weeks   |
| <b>Microchip:</b>          | ISO 11784/11785 (must be implanted BEFORE rabies vaccination)                   |
| <b>Rabies Vaccination:</b> | Required. Minimum 21 days before travel (primary). Keep boosters current.       |
| <b>Titer Test:</b>         | Not required (EU-listed/equivalent origin)                                      |
| <b>Documentation:</b>      | EU Pet Passport with current microchip + rabies records                         |
| <b>Cropping/Docking:</b>   | Dogs with cropped ears or docked tails may face import restrictions in Austria  |
| <b>Insurance:</b>          | Mandatory liability insurance in some regions/states of Austria                 |
| <b>Registration:</b>       | Heimtierdatenbank registration within 1 month of arrival                        |
| <b>Entry Points (BIP):</b> | Vienna-Schwechat (primary), also Linz, Salzburg, Innsbruck, Graz, Klagenfurt    |
| <b>Dog Tax:</b>            | €120/year first dog, €160/year additional dogs (Vienna, effective 2026)         |
| <b>Import Authority:</b>   | BAVG (Bundesamt für Verbrauchergesundheit / Federal Office for Consumer Health) |

### USEFUL TIPS

- Start the process as early as possible. Delays with lab results or vet appointments can push back your timeline significantly.
- Research airline pet policies early. Some airlines have limited cargo spots, especially in summer. Temperature embargoes apply above 30C / below -5C at any transit airport.
- Start crate training weeks before travel. A calm, crate-confident dog will have a much less stressful journey.
- Non-EU arrivals into Austria must enter through an approved Border Inspection Post (BIP): Vienna-Schwechat (primary), also Linz, Salzburg, Innsbruck, Graz, Klagenfurt.
- Make 2 copies of every document (microchip cert, vaccination record, AHC, airline confirmation). Keep originals in your carry-on and copies in checked luggage.

### PRE-TRAVEL CHECKLIST

#### EARLY PREPARATION

- Confirm your dog's breed is permitted in Austria
- Research airline pet policies and book cargo/cabin spot
- Purchase IATA-approved travel crate (correct size for your dog)
- Begin crate training
- Submit pre-arrival notification (18-hour advance notification to border veterinarian)

#### MEDICAL REQUIREMENTS

- Microchip implanted (ISO 11784/11785) -- BEFORE vaccination
- Rabies vaccination administered (min. 21 days before travel)

#### DOCUMENTATION

- EU Pet Passport up to date with current microchip + rabies records
- All vaccination records compiled
- Copies of all documents made (2 sets)
- Airline booking confirmation printed

#### TRAVEL DAY

- All original documents in carry-on bag
- Crate labeled with your name, phone, destination, and 'Live Animal'
- Water dish filled and attached inside crate
- Arrive at airport early (3+ hours for international with pet)

#### AFTER ARRIVAL IN AUSTRIA

- Present documents at Travellers' Point of Entry / Border Control
- Register dog in Heimtierdatenbank within 1 month
- Register with local veterinarian
- Check regional insurance requirements and obtain liability insurance if required
